- CAP EXISTING COLD & HOT WATER PIPING AT THIS POINT.
 - CONTRACTOR SHALL REMOVE THE EXISTING WATER COOLER AND PROVIDE NEW WALL SUPPORT FOR THE WATER COOLER.
 - REMOVE EXISTING 2 COMPARTMENT SINK IN ITS ENTIRETY. REMOVE SANITARY PIPING TO BELOW FIN. FLOOR AND CAP, REMOVE DOMESTIC COLD & HOT PIPING BACK TO MAIN BRANCH AND CAP, REMOVE VENT PIPING BACK TO MAIN BRANCH AND CAP.
 - REMOVE EXISTING LAVATORY SINK & WATER CLOSET IN THEIR ENTIRETY. REMOVE DOMESTIC WATER PIPING BACK TO POINT SHOWN ON PLANS AND CAP, REMOVE SANITARY PIPING TO BELOW FIN. FLOOR AND CAP. REMOVE VENT PIPING BACK TO MAIN BRANCH AND CAP.
 - ALL PLUMBING FIXTURES, & FLOOR DRAINS LOCATED IN THE MEN'S AND WOMAN'S SHOWER ROOM ARE TO REMAIN. REFER TO NEW WORK FLOOR PLAN PLUMBING FOR SERVICE CONNECTIONS TO NEW FIXTURES IN THIS AREA.
 - EXISTING GAS SERVICE PIPING UP ON EXTERIOR WALL UP TO SECOND FLOOR CEILING.
 - EXISTING 1" CW, 3/4" HW. AND 4" SANITARY PIPING UP TO SECOND FLOOR LEVEL.
 - EXISTING TO REMAIN 1/2" CW, & HW. RISERS AND 2" SANITARY RISER PIPING AT THIS POINT AND CAP. CAP SANITARY PIPING BELOW FINISHED FLOOR.
 - REMOVE EXISTING WATER COOLER, DOMESTIC CW, & 1-1/2" SANITARY PIPING TO REMAIN FOR RECONNECTION OF NEW WATER COOLER.
 - SAW CUT THE EXISTING FINISHED FLOOR FOR THE REMOVAL OF THE EXISTING 2" SANITARY PIPING.
 - REMOVE EXISTING WATER COOLER IN ITS ENTIRETY TO INCLUDE DOMESTIC CW, & SANITARY. CAP THE EXISTING DOMESTIC WATER AND SANITARY PIPING AND ABANDONE IN PLACE.
